## Conditions of Entry

Each artist may submit the following:

UP TO 1 to 2 PAINTINGS- Maximum TOTAL width allowed 1.2 metre

(Whether one or two paintings)

OR UP TO 1 to 2 SCULPTURES- 1meter H X 50cm W X 50cm Depth for each work.

Plus up to 3 unframed paintings (Unstrung and presented in protective cellophane)

1. ALL ARTWORKS FOR SALE
2. All artworks must be original, & totally the work of the artist, no work produced in workshops or copies of any kind will be accepted.
3. Artworks can be photographed and used by the society for promotional purposes.
4. All work is to be well framed or on a gallery style canvas with staple free edges. All edges of canvas to be painted & suitably fitted with cord or coated wire.
5. Unframed canvases must have all the sides of the canvas painted.
6. Sculptures must be stable and pieces securely attached
7. The hanging committee reserves the right to reject any damaged or marked frames & artwork.
8. Artist's name, title, medium and price must be on the back of all paintings.
9. Professional artists should supply their ABN.
10. Oils should be dry, and pastels and watercolour must be framed under glass.
11. A commission of 20% applies to all items sold.
12. All possible care will be taken of exhibits, but no responsibility will be accepted for loss or damage.
13. Artists are urged to seek insurance for their artwork entries as TADAS will not be responsible for any loss or damage of their entries
14. All work must be less than 3 years old and can only be displayed in the general exhibitions once per calendar year.
