Conditions of Entry for Applied Art

- To qualify for submitting Applied Arts, it is a requirement that Hanging Art or Sculpture must be submitted as well.
- To exhibit a member must undertake 7 hours (2 shifts) of duty per month.
- Applied Arts items can only be submitted once annually
- 20% commission is applicable to all items.

Definition of Applied Art

- Application of design/decoration to objects that are functional & created to achieve a purpose.
- Examples of Applied Art items.
 - Handmade Cards – original artwork in cellophane bags (not zip lock bags). Phased in and will be disallowed from the changeover on 22nd July 2021
 - Candle Making
 - Handmade Jewellery
 - Leathercraft
 - Pottery/Ceramics
 - Wood Carving, Pyrography

No clothing, textiles, furniture, hanging or framed art (these are to be submitted under Hanging Art with the restrictions that apply).

Any printed items will be disallowed from the changeover on 22nd July 2021

Quality

- The quality of Applied Art MUST be of a gallery standard.

Numbers of Items:

- **Up to 25 ITEMS** which have been approved by the Applied Arts Director.
- Number accepted will be dependent on size of item, variety, numbers in a set & space availability. Items should generally fit into the glass cubes.

Replacements

- Artworks which have been sold may be replaced with similar approved items and must be recorded on a replacement form signed in by the office duty person

New Applied Art

- If you have not entered Applied Art previously or wish to add to your range it must be reviewed by the Applied Arts Director preferably at least 2 weeks **PRIOR** to change-over. An appointment with the Applied Art Director can be made at the office.

Labels

- Each item must be clearly labelled with a removeable sticky label or tie-on **label with artists initials/number and price** (whole dollars only).
- The label must be easy to remove at point of sale.
- Instructions for use and display labels must be professionally presented

Jurying will be undertaken by the Applied Arts Director for any unsuitable items. The decision can be reviewed at the next Committee meeting provided any issues are discussed first with the Applied Arts Director and then presented in writing or email to toukleyartgallery@gmail.com.
